<p><b>Continued training requirements</b></p>	<p>Practitioners must ensure they are up to date with relevant issues and clinical skills relating to immunisation and management of anaphylaxis, with evidence of appropriate Continued Professional Development (CPD).</p> <p>Practitioners should be constantly alert to any subsequent recommendations from Public Health England and/or NHS England and other sources of medicines information.</p> <p>Note: The most current national recommendations should be followed but a Patient Specific Direction (PSD) may be required to administer the vaccine in line with updated recommendations that are outside the criteria specified in this PGD.</p>

#### 4. Clinical condition or situation to which this PGD applies

<p><b>Clinical condition or situation to which this PGD applies</b></p>	<p>Indicated for the active immunisation of individuals with an underlying medical condition which puts them at increased risk from <i>Neisseria meningitidis</i> groups A, C, W and Y, in accordance with the recommendations given in <a href="#">Chapter 7</a> and <a href="#">Chapter 22</a> of Immunisation Against Infectious Disease: 'The Green Book'.</p>
<p><b>Criteria for inclusion</b></p>	<p>Individuals who:</p> <ul style="list-style-type: none"> <li>• are at increased risk of invasive meningococcal infection with asplenia, splenic dysfunction or complement disorders (including those on, or to commence, complement inhibitor treatment eg eculizumab)</li> </ul> <p>Note: This includes individuals with medical conditions accompanied by functional hyposplenism (eg sickle cell disease) but does not include those with coeliac disease unless concurrent hyposplenism has been diagnosed.</p>
<p><b>Criteria for exclusion<sup>2</sup></b></p>	<p>Individuals for whom no valid consent has been received</p> <p>Individuals who:</p> <ul style="list-style-type: none"> <li>• have had a confirmed anaphylactic reaction to a previous dose of the vaccine or to any constituent or excipient of the vaccine, including diphtheria toxoid, CRM 197 carrier protein (Menveo<sup>®</sup>), tetanus toxoid (Nimenrix<sup>®</sup>)</li> <li>• have received MenACWY conjugate vaccine over 1 year of age and in the last 12 months (excluded as they are adequately immunised)</li> <li>• are not at increased risk of invasive meningococcal infection and require routine MenACWY vaccination</li> <li>• are a contact of <i>Neisseria meningitidis</i> groups A, C, W and Y disease</li> <li>• require vaccination for occupational health reasons eg laboratory workers working with meningococci</li> <li>• require vaccination for the purpose of travel</li> <li>• are suffering from acute severe febrile illness (the presence of a minor infection is not a contraindication for immunisation)</li> </ul>
<p><b>Cautions including any relevant action to be taken</b></p>	<p>The immunogenicity of the vaccine could be reduced in immunosuppressed subjects. Vaccination should proceed in accordance with national recommendations. However, re-immunisation may need to be considered. Seek medical advice as appropriate.</p> <p>Syncope (fainting) can occur following, or even before, any vaccination especially in adolescents as a psychogenic response to the needle injection. This can be accompanied by several neurological signs such as transient visual disturbance, paraesthesia and tonic-clonic limb movements during recovery. It is important that procedures are in place to avoid injury from faints.</p>

<sup>2</sup> Exclusion under this PGD does not necessarily mean the medication is contraindicated, but it would be outside its remit and another form of authorisation will be required

<p><b>Action to be taken if the patient is excluded</b></p>	<p>Individuals who have received MenACWY conjugate vaccine over 1 year of age and in the last 12 months do not require a further dose of MenACWY conjugate vaccine when diagnosed at risk.</p> <p>Individuals who are not at increased risk of invasive meningococcal infection and require routine MenACWY vaccination or who are a contact of <i>Neisseria meningitidis</i> groups A, C, W and Y disease should be vaccinated in accordance with PHE recommendations (see MenACWY PGD).</p> <p>Individuals requiring vaccination for occupational health reasons, eg laboratory workers working with meningococci, should be referred to their occupational health service provider for vaccination.</p> <p>Individuals requiring vaccination solely for the purpose of travel should be referred to the appropriate travel immunisation service. MenACWY vaccine is not available on the NHS for the purpose of travel.</p> <p>Individuals suffering from acute severe febrile illness should postpone immunisation until they have recovered. Immunisers should advise when the individual can be vaccinated and ensure another appointment is arranged.</p> <p>Seek appropriate advice from the local Screening and Immunisation Team, local Health Protection Team or the individual's clinician as required.</p> <p>The risk to the individual of not being immunised must be taken into account.</p> <p>Document the reason for exclusion and any action taken in the individual's clinical records.</p> <p>In a GP practice setting, inform or refer to the GP or a prescriber as appropriate.</p>
<p><b>Action to be taken if the patient or carer declines treatment</b></p>	<p>Informed consent, from the individual or a person legally able to act on the person's behalf, must be obtained for each administration.</p> <p>Advise the individual/parent/carer about the protective effects of the vaccine, the risks of infection and potential complications of disease.</p> <p>Document advice given and the decision reached.</p> <p>In a GP practice setting, inform or refer to the GP as appropriate.</p>

<p><b>Legal category</b></p>	<p>Prescription only medicine (POM)</p>
<p><b>Black triangle ▼</b></p>	<p>No.</p>
<p><b>Off-label use</b></p>	<p>Administration by deep subcutaneous injection to individuals with a bleeding disorder is off-label administration in line with advice in <a href="#">Chapter 4</a> and <a href="#">Chapter 22</a> of 'The Green Book'.</p> <p>Menveo<sup>®</sup> is off-label for children under 2 years of age and Nimenrix<sup>®</sup> is licensed from 6 weeks of age, for a schedule with a minimum 2 month interval between doses, but either vaccine is recommended in accordance with advice in <a href="#">Chapter 7</a> and <a href="#">Chapter 22</a> of 'The Green Book'.</p> <p>Vaccine should be stored according to the conditions detailed in the <a href="#">Storage section</a> below. However, in the event of an inadvertent or unavoidable deviation of these conditions refer to <a href="#">PHE Vaccine Incident Guidance</a>. Where vaccine is assessed in accordance with these guidelines as appropriate for continued use this would constitute off-label administration under this PGD.</p> <p>Where a vaccine is recommended off-label consider, as part of the consent process, informing the individual/parent/carer that the vaccine is being offered in accordance with national guidance but that this is outside the product licence.</p>
<p><b>Route / method of administration</b></p> <p>Continued over page</p>	<p>The MenACWY vaccines must be reconstituted in accordance with the manufacturers' instructions prior to administration.</p> <p>Following reconstitution, MenACWY conjugate vaccine should be given as a single 0.5ml dose by intramuscular injection, preferably in</p>

<p><b>Route / method of administration</b> (continued)</p>	<p>the deltoid region of the upper arm. The anterolateral aspect of the thigh is the preferred site for infants under one year old.</p> <p>The MenACWY conjugate vaccines must not be given intravascularly or intradermally and must not be mixed with other vaccines in the same syringe.</p> <p>For individuals with a bleeding disorder, vaccines normally given by an IM route should be given by deep subcutaneous injection to reduce the risk of bleeding (see 'The Green Book' <a href="#">Chapter 4</a>).</p> <p>When administering at the same time as other vaccines care should be taken to ensure that the appropriate route of injection is used for all the vaccinations. The vaccines should be given at separate sites, preferably in different limbs. If given in the same limb, they should be given at least 2.5cm apart. The site at which each vaccine was given should be noted in the individual's records.</p> <p>The vaccine should be inspected visually for any foreign particulate matter and/or variation of physical aspect before reconstitution and following reconstitution prior to administration. In the event of either being observed, discard the vaccine.</p> <p>It is recommended that the vaccine be administered immediately after reconstitution, to minimize loss of potency. Discard reconstituted vaccine if it is not used within 8 hours (see Storage section). The SPCs for Menveo® and Nimenrix® provide further guidance on reconstitution and administration and are available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>
<p><b>Dose and frequency of administration</b></p>	<p><b>Individuals under 1 year of age</b></p> <p>Individuals under 1 year of age, with asplenia, splenic dysfunction or complement disorders, should receive:</p> <ul style="list-style-type: none"> <li>• two doses of MenACWY vaccine at least one month apart during infancy, and</li> <li>• one dose of MenACWY vaccine after the first birthday. This dose should be administered at least two months after the routine Hib/MenC booster vaccination</li> </ul> <p>Where possible the course should be completed with the same brand of MenACWY vaccine. However, vaccination should not be delayed and either vaccine can be given.</p> <p><b>Individuals over 1 year of age</b></p> <p>Individuals over 1 year of age, with asplenia, splenic dysfunction or complement disorders, require a single dose of MenACWY vaccine on presentation.</p> <p>Refer to Green Book <a href="#">Chapter 7</a> for a practical schedule for immunising individuals with asplenia, splenic dysfunction or complement disorders which takes into account the other vaccines required by these individuals.</p>
<p><b>Duration of treatment</b></p>	<p>See dose section above</p>
<p><b>Quantity to be supplied / administered</b></p>	<p>Single dose of 0.5ml per an administration</p>

<b>Supplies</b>	<p>Vaccine for the national immunisation programme should not be used for the vaccination of at risk individuals. Vaccine should be ordered from the manufacturer.</p> <p>Protocols for the ordering, storage and handling of vaccines should be followed to prevent vaccine wastage (see <a href="#">protocol for ordering storage and handling of vaccines</a> and Green Book <a href="#">Chapter 3</a>).</p>
<b>Storage</b>	<p>Store between +2°C to +8°C. Store in original packaging in order to protect from light. Do not freeze.</p> <p>In the event of an inadvertent or unavoidable deviation of these conditions, vaccine that has been stored outside the conditions stated above should be quarantined and risk assessed for suitability of continued off-label use or appropriate disposal. Refer to <a href="#">PHE Vaccine Incident Guidance</a>.</p> <p>After reconstitution, the vaccine should be used immediately. However, stability after reconstitution has been demonstrated for 8 hours below 25°C (below 30°C for Nimenrix®). Discard any reconstituted vaccine not used within 8 hours.</p>
<b>Disposal</b>	<p>Equipment used for immunisation, including used vials, ampoules, or discharged vaccines in a syringe or applicator, should be disposed of safely in a UN-approved puncture-resistant 'sharps' box, according to local authority regulations and guidance in the <a href="#">technical memorandum 07-01: Safe management of healthcare waste</a> (Department of Health, 2013).</p>
<b>Drug interactions</b>	<p>Immunological response may be diminished in individuals receiving immunosuppressant treatment. Vaccination is recommended even if the antibody response may be limited.</p> <p>May be given at the same time as other vaccines.</p>
<b>Identification &amp; management of adverse reactions</b>	<p><b>Menveo®</b> The most common adverse reactions observed after administration of Menveo® vaccine are drowsiness, malaise, headache, nausea, irritability and injection site pain, erythema and induration. Fever, chills, nausea, vomiting, diarrhoea, eating disorders, myalgia, arthralgia and rash are also listed as common side effects.</p> <p><b>Nimenrix®</b> The most common adverse reactions observed after administration of Nimenrix® vaccine are drowsiness, fatigue, headache, loss of appetite, irritability, fever and injection site pain, erythema and induration.</p> <p>Gastro-intestinal symptoms (including nausea, vomiting and diarrhoea) and injection site haematoma are also listed as common side effects.</p> <p>A detailed list of adverse reactions associated with Menveo® or Nimenrix® is available in the SPCs for the vaccine, which is available from the electronic Medicines Compendium website: <a href="http://www.medicines.org.uk">www.medicines.org.uk</a></p>

<b>Reporting procedure of adverse reactions</b>	<p>Healthcare professionals and individuals/parents/carers are encouraged to report suspected adverse reactions to the Medicines and Healthcare products Regulatory Agency (MHRA) using the Yellow Card reporting scheme at: <a href="http://yellowcard.mhra.gov.uk">http://yellowcard.mhra.gov.uk</a></p> <p>Any adverse reaction to the vaccine should be documented in the individual's record and the individual's GP should be informed.</p>
<b>Written information to be given to patient or carer</b>	<p>Offer marketing authorisation holder's patient information leaflet (PIL) provided with the vaccine.</p> <p>Immunisation promotional material may be provided as appropriate:</p> <ul style="list-style-type: none"> <li>• <a href="#">Splenectomy leaflet</a></li> </ul> <p>Available from: <a href="http://www.gov.uk/government/collections/immunisation">www.gov.uk/government/collections/immunisation</a></p>
<b>Patient advice / follow up treatment</b>	<p>Menveo® or Nimenrix® will only confer protection against <i>Neisseria meningitidis</i> group A, C, W and Y. The vaccine will not protect against any other <i>Neisseria meningitidis</i> groups. Individuals should continue to seek prompt medical attention at the first signs of possible meningitis or septicaemia.</p> <p>Inform individual/parent/carer of possible side effects and their management.</p> <p>The individual/parent/carer should be advised to seek medical advice in the event of a severe adverse reaction.</p> <p>When applicable, advise the individual/parent/carer when a subsequent dose is due.</p> <p>When administration is postponed advise the individual/parent/carer when to return for vaccination.</p>
<b>Special considerations / additional information</b>	<p>Ensure there is immediate access to adrenaline (epinephrine) 1 in 1000 injection and access to a telephone at the time of vaccination.</p> <p>Medical conditions such as coeliac disease, sickle cell disease and other haemoglobinopathies may be accompanied by functional hyposplenism. However, hyposplenism in coeliac disease is uncommon in children, and the prevalence correlates with the duration exposure to gluten. Therefore, individuals diagnosed with coeliac disease early in life and well managed are unlikely to require additional MenB vaccine. Only those with known splenic dysfunction should be vaccinated in accordance with this PGD.</p> <p>Individuals receiving complement inhibitor therapy (eculizumab) are at heightened risk of meningococcal infection and should be vaccinated with both MenACWY and MenB vaccines (see MenB Risk Groups PGD), ideally at least two weeks prior to commencement of therapy.</p> <p>Meningococcal vaccines may be given to pregnant women when clinically indicated. There is no evidence of risk from vaccinating pregnant women or those who are breast-feeding with inactivated virus or bacterial vaccines or toxoids</p> <p>Each brand of vaccine uses a different carrier protein and the healthcare professional should refer to the SPCs supplied with the vaccine if there has been a previous hypersensitivity reaction to vaccination.</p>
